## **PASTOR'S PEACE**

This past month our congregation held its annual meeting. Being January, the weather was not the best, which dampened Sunday morning attendance. But there were more than enough congregants present for a quorum so that the work of the day could get done. Written reports from our church's organizations and ministries were presented. An end-of-the-year financial report underscoring that we met budget and that there was no deficit was also shared with oral explanation. Then we turned to the business of the new year. A proposed unified budget for 2020 was approved. Finally, a slate of candidates for our Church Council was formally placed in nomination and unanimously approved by everyone gathered. Elected were Tim Ruffner (first vice-president), Jim Poet (second vice president), Jane Dykowski (secretary), Terri Staffeld (deacon), Mark Ennis (elder), and Michael Isaacs (trustee). Both Mark Ennis and Michael Isaacs were returning for second three-year terms. Everyone elected joins Michele McNeely (president), Dan Case (treasurer), Barb Schultz (elder), Christine Schwab (elder), Dee Salisbury (deacon), James Nault (deacon), Dave Badarak (trustee), and Toni Hill (trustee).

St. Paul members present and participating in the congregational meeting with outgoing Council president Pam Lange presiding walked away satisfied that the good business of our church had been handled effectively and efficiently. More personally, the morning left me proud of our ministry together here. Following a congregational model of organization, our United Church of Christ congregations are among the relatively few religious bodies in America where church members from the pews make—under God's guidance--the ultimate decisions about how we are going to conduct our affairs and put resources to work for Christ. Although it is easy to take it all for granted, this self-governance is a privilege and a blessing.

Happily, our new and continuing Council members take both our congregational organization and their leadership responsibilities on our behalf seriously. On this first weekend in February, they will all join in a day-long leadership retreat in which they take the opportunity to get to know one another better; share in bible study; learn more about our church and its traditions; better discern the different gifts and talents among us; and reflect on common goals and priorities for the year ahead so that we are offering our own members and the wider community the best ministry possible. Our Council members' participation in the day retreat is just one more example of the commitment that each of them bring to our Christian life together.

I ask you to keep our Council members in your prayers in the weeks ahead. Your appreciative encouraging words to them will also mean a lot, helping confirm their call to serve and ensuring that the work ahead for them for Jesus and for us is not a thankless task. I hope that our Council members' example of service can also be an inspiration to the rest of us to say "yes" when an invitation to leadership comes to any of us.

It's also important for us to thank both Pam Lange and Kristi Caruso for their service. Each finished their term and now turn to other pursuits. Each, however, have vowed to remain active in serving our church and its ministry in other ways. Their faithful servanthood offers one more good example for us all.

### **Proposed By-Law Changes January 12, 2020**

The proposed By-Law changes were reviewed and agreed upon at the Annual Meeting on Sunday, January 12, 2020, final vote to change By-Laws will occur on Sunday, July 12, 2020.

Article 6 Governing Body Section 6.1

The governing body of this Church shall be the membership assembled in Church meeting. The vote of a majority of voting members present at the meeting shall be the action of the Church. A quorum shall consist of 10% of the voting membership according to the latest figures in the yearbook of the United Church of Christ, as shown in the official Church records.

Article 10 Church Staff Section 10.1 Pastor

~~c) The salary of the Pastor shall be mutually agreeable to both the Pastor and the Church Council. Such salary shall be paid in monthly installments and reviewed annually. Contributions to the Pastor's Pension Fund will be made by the Church. Contributions to the Pastor's Health Insurance Program will be made by the Church and the Pastor on terms agreeable to both. The Pastor will be furnished housing and all utilities will be paid by the Church. The total compensation package of the Pastor shall be mutually agreeable to both the Pastor and the Church Council. The Trustees shall negotiate a total benefit package for the Pastor including Compensation, Pension Fund, Health Insurance, Housing Allowance, and other matters as deemed appropriate.~~

Article 10 Church Staff Section 10.3 Financial Secretary

Add: d) The Financial Secretary shall report to the Treasurer in all financial matters.

Article 11 Cabinet Section 11.1

~~The Cabinet shall consist of the Church Council and the officers of the Church organizations.~~ The Cabinet shall consist of the following Church Council members (President, 1st Vice-President, 2nd Vice President, Recording Secretary, Treasurer, (1) Deacon, (1) Elder and (1) Trustee and the Officers of the Church organizations and ministries. The purpose of the Cabinet is to coordinate and promote the entire program of the Church. It shall meet at least semi-annually and be subject to the call of the Church Council. The Cabinet shall make recommendations but not set policy for the Church.

Article 12 Ministries Section 12.1

The President of the Church Council shall appoint all Ministries necessary to the work of the Congregation. Following are the standing Ministries:

- Budget Ministry
- Christian Education Ministry
- ~~Evangelism Ministry - Drop~~
- Memorial / Endowment Ministry
- Resource Development Ministry
- Worship/Music Ministry - Add Music

- Financial Advisory Ministry
- Security and Safety Ministry - Add
- Health Ministry - Add

DROP: b) The Chairperson of a Ministry may be appointed for three consecutive terms, if they so desire, but limited to three (3) consecutive years.

Section B Duties of Church Council Section B.4 Deacons

c) One of the Deacons shall be a member of the Worship/Music Ministry.
